1 Introduction

- 1.1 This Adequacy of Consultation Milestone (AoCM) Report has been prepared on behalf of SEGRO Properties Ltd and SEGRO (EMG) Ltd (referred to as 'SEGRO' or the 'Applicant'). It relates to the proposed development referred to as 'East Midlands Gateway 2' (EMG2) and 'the Scheme'.
- 1.2 EMG2 is a second phase of the East Midlands Gateway Logistics Park ('EMG1') which is a Strategic Rail Freight Interchange (SRFI) located to the north of East Midlands Airport in North West Leicestershire. EMG1 is a nationally significant infrastructure development comprising a rail freight terminal and warehousing. It was authorised by The East Midlands Gateway Rail Freight Interchange and Highway Order 2016 (SI 2016/17) ('the EMG1 DCO') and is substantially complete.
- 1.3 EMG2 comprises the following components:
 - <u>EMG2 Main Site</u> a new multi-unit logistics/industrial development located south
 of East Midlands Airport and the A453, and west of the M1 motorway. This part of
 the site falls within the 'East Midlands Airport and Gateway Industrial Cluster'
 (EMAGIC) site, which forms part of the East Midlands Freeport ('Freeport')
 designated by the Government in 2022;
 - <u>Highways Works</u> works to the highway network including significant improvements at Junction 24 of the M1 (referred to as 'J24 Improvements') and the road network interacting with that junction. Due to the scale (and area) of the Highways Works, they represent an NSIP in their own right; and
 - <u>EMG1 Works</u> the proposals include changes within EMG1, incorporating additional warehousing on Plot 16 together with works to increase the permitted height of the cranes at the rail-freight terminal, improvements to the public transport interchange and site management building.
- 1.4 An application for a development consent order (DCO) is proposed to be submitted by SEGRO Properties Ltd for the EMG2 Main Site and the Highway Works.
- 1.5 An application for a material change order (MCO) to the EMG1 DCO is proposed to be submitted by SEGRO (EMG) Ltd for the EMG1 Works.
- 1.6 The applications for the DCO and MCO are proposed to be made at the same time to enable them to be determined together, and given the synergies and interactions between them have been presented as three elements of a single development scheme throughout statutory consultation.

Purpose of the AoCM

- 1.7 This AoCM Report is intended to fulfil the requirements of the *Nationally Significant Infrastructure Projects: 2024 Pre-application Prospectus* ('the Prospectus') published in May 2024. It sets out how SEGRO Properties Ltd has, in respect of the proposed DCO application, complied with the consultation and publicity requirements prescribed by Sections 42, 46, 47 and 48 of the Planning Act 2008 ('PA 2008'), associated provisions of The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ('the EIA Regulations') and The Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 ('the APFP Regulations') (as amended). It further sets out how SEGRO (EMG) Ltd has, in respect of the proposed MCO application, complied with the consultation and publicity requirements prescribed by The Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 ('the Change Regulations').
- 1.8 The guidance in the Prospectus requires the following:

"a written submission to the Inspectorate which establishes the consultation undertaken to date, confirms the approaches set out in the Statement of Community Consultation, and summarises the consultation responses and the way in which they are shaping the application"

- 1.9 This AoCM Report is being submitted to the Planning Inspectorate ('PINS') in advance of the intended submission date for the DCO and MCO applications, and it follows the conclusion of the statutory public consultation undertaken by the Applicant between February and March 2025. As required by the guidance in the Prospectus, this AoCM Report is provided to allow consideration by PINS (and the Applicant) of progress against the agreed Statement of Community Consultation ('the SoCC'), and any additional engagement which may be required in advance of submission of the applications.
- 1.10 The key local authorities for consultation about the SoCC for EMG2 are North West Leicestershire District Council ('NWLDC'), and Leicestershire County Council ('LCC'). A draft SoCC was shared with these two authorities on 18th October 2024, and responses to that draft were received by email and verbally from both within the required 28-day period. These comments and suggestions led to changes being made to the final SoCC. The changes included:
 - Changes (a reduction) in the number of venues to accommodate hard copies of consultation material – reduced to two from a proposed three (removing the Applicant's suggestion of posting a set at LCC's County Hall at the request of LCC);
 - Expanding the 'core consultation area' identified by the Applicant to ensure that communities likely to have an interest in the Highways Works around M1 Junction

- 24 (but with a less direct relationship with the EMG2 Main Site) would receive direct communication regarding the proposals and statutory consultation process;
- Including additional local newspapers on the list for publication of statutory notices regarding the SoCC and for providing details about future consultation events, ensuring a wider coverage into parts of Nottinghamshire and Derbyshire as well as Leicestershire;
- Amendments to ensure the SoCC was clear regarding the ways in which people could engage with the consultation process, with additional specific details included regarding the proposed consultation methods and timing.
- 1.11 Having taken these various comments into account, the Applicant finalised and published the SoCC in December 2024. A copy of the SoCC is attached to this AoCM Report at **Appendix 1**.
- 1.12 The SoCC includes an overview of the informal pre-application engagement and consultation undertaken including that already completed at the date of publication defined within 'Stage 1' of the consultation strategy while also defining the approach to the statutory consultation required ('Stage 2').
- 1.13 The Applicant's consultation and engagement strategy has consequently involved more than one stage, including informal engagement as well as statutory consultation covering a range of activities to ensure appropriate and meaningful awareness and opportunities to comment on and influence the emerging proposals. This, and the results and outcomes of the consultation processes, will be set out in detail in due course in the Consultation Report which will form part of the DCO and MCO applications to PINS. In the interim, this AoCM Report describes the consultation processes undertaken and identifies consultation outcomes which are informing the preparation and evolution of the proposals for the Scheme and the applications.
- 1.14 This AoCM Report is structured as follows:
 - Pre-application consultation and engagement, including with NWLDC and LCC (Section 2);
 - Details as to how the statutory consultation was carried out, with reference to the adopted SoCC (Section 3);
 - Outcome of the statutory consultation process (Section 4);
 - Summary conclusions and next steps (Section 5).

2 Pre-Application Consultation and Engagement

Background and overview of the proposals

2.1 The Scheme's origins are as a planning application being prepared under the town and country planning process for the EMG2 Main Site only, and initial consultation and engagement activities undertaken were in this context. That activity included early engagement in pre-application (planning) consultation with NWLDC as the local planning authority which has continued since and throughout. The Applicant also undertook a range of informal, localised activities to engage with and consult representatives of the local community and consultee bodies.

Although the proposals subsequently evolved, with the site and description of development changing, that early engagement and dialogue represents part of the iterative process that has informed the current Scheme and is directly relevant as part of the informal pre-application engagement and consultation.

2.2 Table 1 below summarises the details of the structure and elements of the consultation processes, and other key milestones, of relevance to this AoCM Report, and shows how the informal pre-application consultation and engagement forms part of the overall consultation undertaken:

Early informal engagement and consultation

- 2.3 The Applicant engaged with local and statutory groups and bodies from an early stage, and this had a direct influence on the nature and form of the submitted proposals. This dialogue has taken several forms of consultation and engagement and has taken place over an extended period. This included informal and *ad hoc* (non-statutory) engagement and discussion about the emerging proposals.
- 2.4 During the initial period when the development proposals were being promoted as a planning application focused on the EMG2 Main Site, and highways local to the site beginning in early 2022 informal engagement and consultation was undertaken as part of the pre-application activity.
- 2.5 Informal dialogue and engagement with various bodies was explicitly in the context of the Freeport designation which includes the EMG2 Main Site, and the opportunity (if not an imperative) this created for the EMG2 Main Site to be brought forward for development.
- 2.6 Engagement and consultation at that time focused on informal meetings and briefings with individual local authority officers and members (of NWLDC and LCC), as well representatives of the Freeport or bodies involved in the Freeport and economic

development agenda. Initial contact was also made with the local MP, the local 'action group' (known as 'Protect Diseworth') and with individuals on behalf of surrounding Parish Councils in the vicinity of the EMG2 Main Site. The Applicant also engaged directly with surrounding landowners, including East Midlands Airport, and other landowners with an interest within the EMG2 Main Site and immediate surrounds.

- 2.7 Following early dialogue, and as an early action in beginning to prepare a planning application, the Applicant engaged in seeking formal pre-application consultation and advice from NWLDC (beginning in Spring 2022). As part of this process of pre-application engagement, the Applicant also requested in May 2022 a formal Environmental Impact Assessment ('EIA') Scoping Opinion from NWLDC regarding those initial proposals.
- 2.8 A Transport Working Group ('TWG') was also created by the Applicant in March 2022 in the context of the early planning application. The TWG has met regularly since and includes local and national highways bodies (LCC and National Highways), and NWLDC as local planning authority to provide technical input and scrutiny of the work to prepare a Transport Assessment ('TA') as part of a planning application (or DCO) submission. The TWG has been a key source of engagement on technical highways matters including methodology, data and assumptions to underpin the TA which will form part of the DCO and MCO applications.
- 2.9 An EIA Scoping Opinion was provided by NWLDC in December 2022 having consulted with a wide range of consultees (statutory and local consultees and interested bodies). Following that Scoping Opinion, the Applicant team continued to progress the draft proposals, with ongoing pre-application dialogue with NWLDC, and with all relevant other consultees as they progressed work to undertake the EIA.
- 2.10 The awareness raised, and comments received, during this process, alongside the technical work undertaken to progress an EIA and TA for the nascent planning application on the EMG2 Main Site, played an important role in setting the scene for the EMG2 proposals as now proposed. It provided a clear understanding of a number of key local issues and some concerns about the potential impact of development in this location, both from the community and other consultees, which played a direct role in informing the evolution of the proposals.
- 2.11 The Secretary of State issued a Direction pursuant to section 35 of the PA 2008 in February 2024 which confirmed that development of the EMG2 Main Site is of national significance, and that it should be brought forward as such for determination by the Secretary of State via an application for Development Consent (as opposed to an application for planning permission to NWLDC). Informal pre-application dialogue and engagement continued after the decision to promote the Scheme as a project of national significance, as did the formal pre-application dialogue with NWLDC who

- remain an important consultee, and source of direction and information regarding local issues, concerns and priorities.
- 2.12 The Applicant has continued to provide informal updates and briefings about the EMG2 proposals to the Freeport Board, as well as to local interest groups and bodies. This has included briefings to Parish Council representatives, including via the EMG1 Community Liaison Group which has met regularly since soon after the approval of the EMG1 DCO (in 2015/16). The Applicant has also met with representatives of the local interest group 'Protect Diseworth', and a local community-based group focused on local flood-risk issues. An explanatory briefing session was also provided by one of the Applicant's consultant team to the Parish Council to provide an overview of the DCO process (to aid the Parish Council's understanding). In addition, the Applicant has engaged with all relevant landowners, as well as occupiers of nearby EMG1 to help inform proposals about the proposed EMG2.
- 2.13 Following the Section 35 Direction and the decision to proceed with a DCO application, a request for a Scoping Opinion was submitted to PINS in August 2024. As part of that process, consultees were consulted again and provided comments to PINS to inform its Scoping Opinion, which was issued on 24 September 2024. Other technical work has continued, including the TWG referred to above.
- 2.14 Therefore, in advance of the statutory consultation processes undertaken as required by the PA 2008, an extensive range of local engagement and consultation was undertaken by the Applicant over an extensive period. As described above, this has included engagement and consultation of both a 'political' and 'technical' nature, and has ensured that the Applicant has been made aware of local views, concerns and ideas from a range of sources from the outset of the Scheme.

3 Statutory consultation

- 3.1 This section of this AoCM report describes the statutory local and public consultation processes and activities. It provides details of the procedural steps taken, the ways in which the Applicant engaged with local people and communities, and also provides details of the material consulted upon.
- 3.2 Under section 47 of the PA 2008, the Applicant is required to consult with the local community, described as "people living in the vicinity of the land". Separate requirements under section 42 of the PA 2008 require the Applicant to consult prescribed consultee bodies and organisations, local authorities and persons with an interest in the land.
- 3.3 Engagement and consultation with relevant consultees has been underway for some time regarding a range of technical topics and issues for development of the Scheme and assessment purposes, but, in addition to this, the Applicant consulted with all relevant consultees formally as part of the statutory consultation and engagement process.
- 3.4 The statutory consultation required by sections 42 and 47 was held for a period of 6 weeks from 3rd February 2025 to 17th March 2025, exceeding the required 28-day period.

Statement of Community Consultation (SoCC)

- 3.5 As described in section 1 of this AoCM report, a SoCC was published by the Applicant in December 2024 following consultation and dialogue with NWLDC and LCC about a draft.
- 3.6 The SoCC details the Applicant's proposed consultation strategy in respect of the proposed development including the statutory consultation identified as 'stage 2' and was prepared in accordance with section 47 of the PA 2008 and the accompanying guidance. The SoCC is at **Appendix 1**.
- 3.7 The consultation strategy focused on raising awareness about the proposals and consultation process with communities and people who both live and work within the local community of the proposed development. While there was a focus on those living and working within the identified 'core consultation area' defined in the SoCC, the Applicant also undertook engagement and awareness raising activities which extended outside of that area.
- 3.8 As committed to in the SoCC, newsletter leaflets were distributed in advance the start of public consultation across the extensive 'core consultation area' which included all

or part of seven parishes¹. More than 7,350 newsletters were distributed to residential and business premises using Royal Mail. The newsletter leaflet is enclosed at **Appendix 2**.

- 3.9 Following local reports that some streets in Diseworth (including Page Lane and Lady Gate), had been missed by the Royal Mail deliveries, newsletters were delivered by hand by the Applicant's team to approximately 70 properties. The Applicant was grateful to have had the apparent localised issue (with some addresses having been initially missed) drawn to its attention, and once aware, responded immediately.
- 3.10 In addition, to further raise awareness of the Scheme and consultation process, newsletters were posted (and emailed) to Parish Council clerks in advance who were encouraged to post or display (physically and/or virtually) the newsletters on local display boards or community online fora. These were sent to all Parish Councils in the 'core consultation area' plus Melbourne Parish Council in South Derbyshire. Clerks also received USBs containing consultation documents for their own use to aid their engagement in the process, as well as to support any local 'hard to reach' groups or individuals who might find it harder to access the same information online or via the hard copies deposited in Castle Donington Library, and at NWLDC's Customer Centre in Coalville from the first day of the consultation period.
- 3.11 As part of the wider awareness raising activity in advance of the formal start of consultation, the Applicant contacted a wide range of consultees and interested parties (individuals and bodies). This was undertaken in writing (via email) to local elected members of both NWLDC and LCC to ensure advanced notice of the consultation process and key dates, including the dates of exhibitions, and the deadline for comments.
- 3.12 Also, as required by the APFP Regulations and the Change Regulations, formal notices of the consultation were posted in local and national newspapers an example is enclosed at **Appendix 3**. These were:
 - Leicester Mercury on 31 January 2025 and 7 February 2025
 - Loughborough Echo on 31 January 2025 and 12 February 2025
 - Derby Telegraph on 31 January 2025 and 7 February 2025
 - Nottingham Post on 31 January 2025 and 7 February 2025
 - London Gazette on 31 January 2025
 - The Times on 31 January 2025
- 3.13 In addition to these 'traditional' press channels, the Applicant also made use of its own website and social media channels to publicise the consultation regarding EMG2. This

was undertaken via a series of posts on Facebook and Instagram to promote the statutory consultation process, provide summary details of the proposals, and direct interested parties to the project website. This was undertaken between 4th February and 4th March 2025, and data captured from the campaign shows adverts reached over 260,000 people with the average person seeing the adverts twice. A total of 409 people clicked on the link from the adverts to access the project website which contained more information about the project and consultation process. This is considered to have made a meaningful contribution to the overall dissemination of information and awareness raising.

- 3.14 Consultees were able to comment via a range of means of communication, as set out in the SoCC, including:
 - Via email (using the online comments form on the project website);
 - In person at the consultation exhibitions verbally, and by completing a comments form;
 - By post (via the PO Box) by sending completed questionnaires or other written correspondence.
- 3.15 In addition, although not identified in the SoCC, through direct contact between members of the Applicant team and local consultees and groups, some queries or comments or requests for further information were emailed direct to the Applicant or their representatives.

Consultation Exhibitions and Webinar

- 3.16 The consultation exhibitions represented a key element of the statutory consultation process, enabling local communities and interested parties to not only review a range of material regarding the proposed development, but also engage directly to ask questions or seek clarifications with members of the Applicant team.
- 3.17 The exhibition display boards were detailed and set out comprehensive information on a range of topics and issues regarding the proposals, and the ongoing EIA process. An electronic copy of the exhibition display boards was also posted on the project website on the date of the first exhibition.
- 3.18 The two consultation exhibitions were held between 3pm and 7pm to ensure opportunities for working people to attend and were held in two different venues in the vicinity of the Scheme (Diseworth Village Hall on 10th February 2025, and East Midlands Airport, Hilton Hotel on 25th February 2025). The first venue was chosen following engagement with Protect Diseworth and in recognition that Diseworth is the closest community to the EMG2 Main Site.

- 3.19 The two exhibitions were well attended, with approximately 266 people attending in total, including 198 attendees at the first event in Diseworth.
- In addition, a consultation webinar was held later in the consultation period (on the evening of 4th March 2025) to ensure anyone unable to attend an exhibition, or anyone else who wished to engage online as opposed to in person, was able to see and hear a presentation from the Applicant team about the Scheme, and had the opportunity to ask questions.
- 3.21 Six people registered in advance to attend the webinar, although only one person attended. The webinar lasted approximately an hour, and a recording of the presentation and discussion, including answers to questions posed during the session, was posted on the project website.

Statutory Consultation undertaken (Section 42)

3.22 The list of bodies consulted under Section 42 (and Sections 43 and 44), and any category 3 parties is enclosed at **Appendix 4**.

Summary of consultation undertaken compared against the SoCC

- 3.23 As set out above, the Applicant undertook the consultation as described in the SoCC.
- 3.24 There was a good level of engagement via the two in-person exhibitions, and a limited level of interest via the webinar.
- 3.25 The consultation process generated the following by way of responses:
 - A total of 205 responses from members of the public, including:
 - o 106 completed 'hard-copy' paper questionnaire response forms;
 - o 97 online response forms via the website; and
 - 2 other emails.
 - A total of 29 responses from statutory consultee bodies.
- 3.26 The table below summarises the key elements of the SoCC regarding the statutory consultee process, and the actions taken:

4 Responses to statutory consultation

- 4.1 The Applicant is mindful of its duty to take account of responses to consultation and publicity (in accordance with Section 49 of the PA 2008). As referred to above, a full Consultation Report is being prepared and will be submitted as part of the DCO and MCO applications and will include an explanation of how statutory consultation responses have been taken into account.
- 4.2 Throughout the informal and non-statutory consultation and engagement, the Applicant has been seeking to respond to local issues and concerns raised by various consultees, and the proposed Scheme consulted upon during statutory consultation reflected changes and amendments in response to earlier input received.
- 4.3 The Applicant has begun to review the initial feedback received through the statutory consultation process, and although that process is ongoing, it is clear from the work so far that there are consistent themes with issues being raised during the earlier, informal engagement and consultation.
- 4.4 Over 260 people attended the consultation exhibitions, and 187 written responses were received from individuals (the public), with a further 29 written responses from consultee bodies. Having read all comments received, the key points and suggestions have been captured and are now forming the basis of discussion and review across the Applicant's project team to consider the points made. Relevant issues will feed into the ongoing work to progress and finalise the application documentation and the iterative process of finalising the proposals, including giving consideration to whether there are further reasonable or necessary changes or clarifications required as the Scheme is finalised ahead of submission of the applications.
- 4.5 In advance of the Consultation Report which will be produced in due course, the Applicant has prepared a summary of the main themes and issues identified through the statutory consultation process. That summary is at **Appendix 5** of this AoCM report and has been published on the project website. The preparation of that summary of key themes and issues was itself a commitment in the SoCC, intended to aid interested parties by providing a precursor to detail to follow in the Consultation Report.

Next Steps

4.6 As part of its review of the responses received, the Applicant is following up in writing and in person with a number of consultees who raised key issues or queries, and a comprehensive Consultation Report will include an explanation of the issues raised and the Applicant's responses to them, and will form part of the DCO and MCO applications in due course.

- 4.7 In addition, there is ongoing engagement with many statutory consultees regarding the ongoing technical work to refine or progress the various application documents and assessments, including completing elements of the EIA such as the TA. A key focus of the ongoing engagement over the coming period in advance of submission of the DCO and MCO applications will be progressing Statements of Common Ground (SoCGs) with key consultees and stakeholders with a view to narrowing any issues and reaching agreement on the scope and content of the DCO and MCO applications. The Applicant is committed to finalising as many SoCGs as possible at or around the time of the DCO and MCO applications being submitted.
- 4.8 The Applicant is satisfied that the statutory consultation undertaken was comprehensive and was undertaken in accordance with the SoCC. As part of its commitment to ongoing consultation and engagement, however, the Applicant is giving consideration to whether there may be value in additional (non-statutory) consultation.

5 Conclusions

- This AoCM Report sets out how the Applicant has undertaken appropriate and suitable consultation in respect of its proposed applications for a DCO for the EMG2 Main Site and the Highway Works, and for a MCO to the EMG1 DCO for the EMG1 Works. Crucially, it demonstrates that the Applicant has undertaken a comprehensive consultation strategy as set out in and in accordance with the agreed SoCC.
- 5.2 The engagement and consultation undertaken has seen use of a range of communication methods with a range of bodies and communities over an extensive period of time. Implementation of the strategy built on the relationships and connections established by the Applicant from their involvement in delivering the successful EMG1 scheme, and as part of early work relating to an initially intended planning application on the EMG2 Main Site.
- 5.3 The level of local engagement in the consultation process, notably at the consultation exhibitions, and the number of comments received to the statutory consultation process, indicates the successful nature of the consultation undertaken. Over 260 people attended the consultation exhibitions, and 187 written responses were received from individuals (the public), with a further 29 written responses from consultee bodies. The online social media promotion reached a very significant number of people (around 260,000) and generated over 400 visits to the project website which contained full details of the proposals and consultation material.
- The Applicant understands the importance of local awareness of the proposals and consultation process to ensure people have the chance to review and comment on draft material, and through the combination of not only the Applicant's direct activities, but also supported by the wider local activities and communication by the Parish Council and the local interest group (Protect Diseworth), there can be no doubt that there was an excellent level of local awareness, and engagement. As stated earlier in this AoCM Report, the Applicant is satisfied that the statutory consultation undertaken was comprehensive and undertaken in accordance with the SoCC. However, as part of that ongoing process, the Applicant is giving consideration to whether there may be value in additional (non-statutory) consultation to provide further updates and details on some key elements of the proposals.
- In summary, this AoCM report confirms that, in respect of the proposed DCO application, the Applicant has complied with the consultation and publicity requirements prescribed by Sections 42, 46, 47 and 48 of the 'PA 2008, the relevant provisions of the EIA Regulations and the APFP Regulations. It also confirms how the

Applicant has complied with the consultation and publicity requirements prescribed by the Change Regulations in respect of the proposed MCO application.

1.0 INTRODUCTION

What is this document?

- 1.1 This Statement of Community Consultation ("SoCC") records how SEGRO Properties Ltd (the "Applicant") will consult the local community on its proposals for Phase 2 of East Midlands Gateway (known as "EMG2" or the "Scheme"). In preparing this SoCC, North West Leicestershire District Council ("NWLDC") and Leicestershire County Council ("LCC") were consulted on the Applicant's consultation strategy. Comments and suggestions received have been discussed and changes incorporated into this final SoCC.
- 1.2 This SoCC has been prepared in accordance with Section 47(1) of the Planning Act 2008 (the "PA 2008")¹ which requires applicants for Nationally Significant Infrastructure Projects ("NSIPs") to "prepare a statement setting out how the applicant proposes to consult, about the proposed application, with people living in the vicinity of the land". The Applicant has also taken into account the guidance on the pre-application stage for NSIPs² produced by the Ministry of Housing, Communities and Local Government (the "Guidance").
- 1.3 This SoCC therefore sets out how the Applicant intends to consult the local community on its proposals, how people can learn more about the Scheme and engage with the process, as well as information about the statutory consultation process. Additionally, it sets out how the Applicant will have regard to consultation responses received.

Overview of the Scheme

- 1.4 The Scheme is a second phase of the existing and operational East Midlands Gateway ("EMG1") which is a Strategic Rail Freight Interchange ("SRFI") located to the north of East Midlands Airport. A SRFI is a large multi-purpose freight interchange and distribution centre connected by rail and road networks.




Figure 1 - Site Location Plan

- 1.5 An illustrative plan showing the location of the Scheme is shown at figure 1 below.
- 1.6 The Scheme comprises three interrelated component parts as follows:
 - EMG2 Main site A new warehousing and manufacturing employment park located south of East Midlands Airport and the A453, and west of the M1 motorway. This part of the Scheme falls within the 'East Midlands Airport and Gateway Industrial Cluster' (EMAGIC) site, which forms part of the East Midlands Freeport designated by the Government in 2022;
 - Highways works Highways works to the strategic road network including improvements at junction 24 of the M1 motorway and the road network interacting with that junction; and
 - EMG1 works Additional warehousing together with works to increase the permitted height of the cranes at the SRFI, improvements to the EMG1 public transport interchange and site management building.

1.7 The Scheme has been identified as 'nationally significant' by a direction of the Secretary of State dated 21 February 2024 ("the Direction"), and should be subject to the same consenting process as an NSIP – also see the 'planning process' section below.

Overview of the planning process

- 1.8 NSIPs are dealt with via a different process to other major planning proposals. Rather than submitting a planning application to the local authority to seek approval for the development, an applicant is required to apply instead to the Planning Inspectorate ("PINS") for a Development Consent Order ("DCO"). The application will ultimately be determined by the Secretary of State following consideration of a report prepared by the examining inspectors appointed by PINS on behalf of the Secretary of State.
- 1.9 Information about the planning process which applies to the Scheme and NSIPs generally is available on the PINS website: http://infrastructure.planninginspectorate.gov.uk/
- 1.10 Following receipt of the application for a DCO from the Applicant, PINS will consider whether the application is of a sufficient standard to be accepted. When considering whether to accept an application, PINS will invite the host local authorities to confirm whether or not the consultation process completed by the Applicant is adequate and conforms with this SoCC. If the application is accepted, then there will be the opportunity for interested parties to register and participate in the "examination" of the application. The examination is undertaken by one inspector or a panel of up to five inspectors known as the "Examining Authority" and is

predominantly a written process but often includes some oral hearings on specific topics. The final decision will be made by the Secretary of State following the examination and after receiving a report prepared by the Examining Authority.

- 1.11 It should be noted that neither NWLDC or LCC are decision making authorities but they do have an important role and will be required to contribute to the examination process. The Applicant's engagement with these authorities is set out in further detail in Section 2 of this SoCC.
- 1.12 As part of the process for determining applications for development consent for NSIPs, the Government has prepared 'National Policy Statements' on a range of infrastructure development, including various types of Energy infrastructure, Transport, Waste, and Water. In 2024, the Government published an updated version of the 'National Policy Statement for National Networks' ("NPSNN")³ which includes specific policy guidance on SRFI developments. The NPSNN and more information can be found via the address in the footnote below, and on the PINS's website guoted above.
- 1.13 There is also a link to the PINS website on the EMG2 webpage which is: www.segro.com/slpemg2

2.0 THE PROPOSED DEVELOPMENT, SITE AND ENVIRONMENTAL IMPACT ASSESSMENT (EIA)

- 2.1 The Applicant's proposals for EMG2 include additional logistics and manufacturing facilities incorporating a substantial logistics campus and co-located headquarters functions for Maersk (a global shipping and logistics company) on land south of East Midlands Airport. EMG2 will be integrated with improvements to the efficiency and freight handling functionality of the SRFI at EMG1. The development will also directly support delivery of the wider East Midlands Freeport.
- 2.2 The proposed development is comprised of three elements. Each element of the Scheme is described in greater detail under sub-headings below. The following paragraphs also summarise the proposed consenting process for the three interrelated component parts which comprise the Scheme.

The EMG2 main site

- 2.3 The proposed development within the EMG2 main site is for a multi-unit logistics/industrial development together with supporting and co-located office functions. The parameters for the proposed development are likely to evolve and be refined further to reflect the outcomes of the environmental impact assessment ("EIA") and consultation processes.
- 2.4 An application for development consent is to be made pursuant to section 37 of the PA 2008 in accordance with the Direction made by the Secretary of State. The Direction confirmed that the Applicant's proposals for the EMG2 main site satisfied the criteria for business and commercial projects and should be treated as a development of national significance for which development consent is required.
- 2.5 A development 'Parameters Plan' will be submitted with the DCO application to define the key development principles and form the basis for the assessment of the development of the EMG2 main site. A draft Parameters Plan will be included in the consultation documentation to identify the following components of the proposed development on the EMG2 main site:
 - A maximum of 300,000 sq.m. of employment floorspace (GIA), and an additional 100,000 sq.m. of mezzanine floors;
 - A series of Development Zones to the north and south of Hyam's Lane where new employment buildings are proposed to be located together with supporting infrastructure;
 - Maximum external building heights for each Development Zone. Maximum finished floor levels (FFL) will also be specified for each Development Zone;
 - Vehicular access from the A453;
 - Landscaping areas and buffers along the site boundaries including new and retained landscape features which will deliver biodiversity enhancements. This will include a significant landscape screen utilising earthworks bunding on the western and southern part of the site. Hyam's Lane is proposed to be retained and provide pedestrian/cycle connectivity through the middle of the site. The landscape areas would include SUDs features;
 - Provision of a new estate road serving the Development Zones; and
 - A bus interchange terminal at the site entrance which replicates and builds upon the successful sustainable travel strategy for the EMG1 site.

2.6 While the application will not seek approval for details of layout or design, an illustrative masterplan will also be consulted upon and be submitted as part of the application, to show how the site *could* come forward based on the Parameters Plan.

Highway Works

- 2.7 It is currently envisaged that, subject to further assessment, safety audits and agreement with highways authorities, the highway works required to facilitate the Scheme will comprise:
 - Provision of site access from the A453;
 - Potential improvements to the wider highway network;
 - Provision of a new shared footpath/cycleway along the A453 connecting the EMG2 main site with facilities at EMG1.
- 2.8 The proposed works to the strategic road network may qualify as a NSIP in their own right. The Applicant is currently liaising with National Highways Limited, as strategic highway authority, to determine whether the works exceed the thresholds in section 22 of the PA 2008. Either as a highways NSIP, or not, the strategic highways works will be included as an integral part of the application for the Scheme.

EMG1 works and Strategic Rail Freight Interchange improvements

- 2.9 It is proposed to increase the functionality of the existing SRFI located within EMG1, to serve occupiers located at both EMG1 and EMG2 and enhance operational handling efficiency at the terminal. The alterations to the SRFI at EMG1 are proposed to comprise:
 - Provision of up to 6.4ha additional warehousing comprising 25,000 sq.m. with 5,000 sq.m. of mezzanine flooring (referred to as 'Plot 16') and/or additional open container storage area;
 - Improvements to the EMG1 SRFI to increase handling functionality and efficiency including through the provision of higher gantry cranes than consented under the EMG1 DCO;
 - Expansion of the management suite to cater for the additional demand on management facilities resulting from EMG2;
 - Public transport enhancements including provision of EV charging infrastructure for buses and provision of a drop-off layby adjacent to the existing transport hub; and
 - Upgrade work to Public Footpath L57.
- 2.10 An application will be made for a material change to The East Midlands Gateway Rail Freight Interchange and Highway Order 2016 pursuant to section 153 and schedule 6 of the PA 2008 to authorise the proposed works at EMG1 ("Material Change Order" or "MCO").

<u>EIA</u>

- 2.11 The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 require the development to be accompanied by an EIA.
- 2.12 The environmental assessment work, presented in an Environmental Statement ("ES"), will be submitted as part of the application. As progress continues in preparing the ES, draft ES

chapters will be used for consultation to serve as the 'Preliminary Environmental Information Report' (PEIR).

2.13 As set out in Section 3 of this SoCC, the draft ES chapters will form part of the consultation processes to aid the ability of consultees to understand the Scheme, the emerging mitigation proposed, and its likely environmental effects. As described below (see paragraphs 3.32 – 3.35), different amounts of detail are likely to be available across topics to inform the various elements of the engagement and consultation activities proposed.

3.0 CONSULTATION STRATEGY

Introduction

- 3.1 This section of the SoCC sets out the details of the consultation strategy. It provides a summary of the early activity undertaken to date, as well as setting out the intended strategy for ongoing consultation whilst the application is being prepared which includes ongoing non-statutory consultation as well as a formal statutory consultation period.
- 3.2 The Applicant's consultation and engagement strategy involves more than one stage of consultation, including informal engagement as well as statutory consultation covering a range of activities to ensure appropriate and meaningful awareness and opportunities to comment on and influence the emerging proposals. In addition, the Scheme's origins as a planning application being prepared under the town and country planning process included initial activities undertaken with regard to consultee and community engagement. That dialogue represents part of the iterative process that has informed the DCO application and will be recorded appropriately in the Consultation Report which will accompany the application. The activities which have already been completed are described below within 'stage 1' under the heading "Early Engagement". This stage also identifies the ongoing and planned non-statutory consultation and engagement activities.
- 3.3 Under section 47 of the PA 2008, the Applicant is required to consult with the local community, described as "people living in the vicinity of the land". This SoCC details the Applicant's proposed consultation strategy in respect of the proposed development including the statutory consultation identified as 'stage 2' and has been prepared in accordance with section 47 of the PA 2008 and the accompanying Guidance. For clarity, the consultation strategy will consider people who both live and work within the local community of the proposed development, and while this will focus on those living within the identified 'core consultation area' defined below, the Applicant will also undertake engagement and awareness raising activities in communities outside of that area.
- 3.4 Separate requirements under section 42 of the PA 2008 require the Applicant to consult prescribed consultee bodies and organisations, local authorities and persons with an interest in the land. Engagement and consultation with relevant consultees has been underway for some time regarding a range of technical topics and issues for development of the Scheme and assessment purposes, but, in addition to this, the Applicant will consult with all relevant consultees more formally as part of the statutory consultation and engagement process.
- 3.5 The proposed consultation strategy will build upon the consultation and engagement the Applicant has already conducted with further consultation throughout the pre-application period. This multiple stage approach is shown in figure 2 below:

Who and where will we be consulting

Core Consultation Area

- 3.6 In accordance with section 47 of the PA 2008, and the Guidance, the Applicant's proposed approach to community consultation seeks to ensure information and opportunity to comment is provided to those most likely to be affected by the Scheme.
- 3.7 Prior to commencing any statutory consultation, the Applicant identified a 'Core Area' for community consultation focusing on the business and residential communities neighbouring the Scheme. This Core Area has been refined for the purposes of this SoCC and was shared for comment and approval with both NWLDC and LCC. Following comments received, the Core Area was expanded to ensure it incorporates communities closest to the proposed Highways Works and to EMG1. This enlarged area is shown on the map at figure 3 below.

3.8 The Core Area includes the communities 'in the vicinity of' the land' where the Scheme will be located and will form the focus of the single statutory consultation comprising stage 2. This stage 2 statutory consultation process is considered in further detail later in this SoCC.

Figure 3: Proposed Core Consultation area:



- 3.9 The Core Area includes all or part of the parishes of:
 - Long Whatton and Diseworth
 - · Lockington cum Hemington;
 - Isley cum Langley;
 - Kegworth;
 - Castle Donington;
 - Breedon on the Hill.
- 3.10 Within the Core Area, individual properties will receive a posted awareness raising leaflet regarding the consultation process. In addition, consultation events (exhibitions) will also be located within the Core Area. It is this which differentiates the Core Area from other areas where there will also be other engagement and awareness raising via Parish Councils and other measures as set out below.
- 3.11 The Applicant intends that Parish Councils both within and outside the Core Area are used as a key point of contact to help ensure wider awareness in the local communities in addition to measures and activity to engage directly with local people and communities. As part of the approach, the Applicant will inform local elected members (and District and County Councillors whose divisions include part of the Core Area) and Parish Councillors within the Core Area of progress at relevant stages leading up to the application as a key part of its ongoing consultation. This will be done by offering and providing briefings and updates through email correspondence. In addition, the intention is to provide electronic copies of the posted leaflet distributed by the Applicant to Parish Clerks. The leaflet will include details of the consultation which Parish Clerks can display locally to further ensure wider local awareness of the proposals

and consultation process, including in those Parishes outside of the Core Area where leaflets will not have been sent to all addresses direct.

How we have and how we will continue to consult

Early Engagement

- 3.12 The initial, early stage of the consultation process is already underway, and has been for some time. Pre-application engagement and dialogue about EMG2 began with the Applicant's proposals to pursue a traditional planning application following designation of the East Midlands Freeport which includes the EMG2 main site. Informal dialogue and engagement was first undertaken in 2022 with various bodies. Engagement at that time focused on briefings provided to officers and informal updates to individual local members of NWLDC and LCC, as well representatives of the East Midlands Freeport. Initial contact was also made with the local MP, landowners, the local 'action group' (known as 'Protect Diseworth') and with individual Parish Councils.
- 3.13 A Transport Working Group was established in March 2022 which involves representatives from the county and district councils as well as National Highways Limited. A wide range of technical highways matters have, and will continue to be, discussed throughout the pre-application period within this group, including key technical methodology, data and assumptions to underpin the Transport Assessment which will form part of the DCO application.
- 3.14 An ES Scoping Opinion request, associated with the planning application, was submitted to NWLDC in May 2022. NWLDC provided a Scoping Opinion in December 2022 having consulted with a range of consultees (statutory and local consultees).
- 3.15 Following the Direction from the Secretary of State pursuant to section 35 of the PA 2008 on February 2024, a request for a Scoping Opinion was submitted to PINS in August 2024 in light of the decision to proceed with a DCO application. As part of that process, consultees were consulted again and provided comments to PINS to inform its Scoping Opinion, which was issued on 24 September 2024.
- 3.16 In addition to the activities already completed, informal non-statutory engagement and consultation is on-going and a summary of the planned activities which will lead up to and inform the statutory consultation process in stage 2 is included in table 1 below.

Statutory Consultation

3.17 The second stage of the consultation process will commence with a **6 week period of statutory consultation commencing in February 2025**. This will exceed the statutory minimum requirement of 28 days (4 weeks). A summary of the planned activities is provided in table 2 below and further details are provided in the text that follows.

Statutory Consultation	An extensive 6 week statutory consultation period starting in February 2025 structured around exhibiting Scheme information at 'in person' events as well as an online event (see paragraphs 3.21 to 3.32 below). The intention is to hold in-person exhibitions a few weeks apart during the consultation period, and an online event towards the end of the consultation period to maximise opportunities for interested persons to engage and contribute. The material displayed at the in-person exhibition (in the form of display

boards) will also be available on the EMG2 webpage throughout the consultation period.

Updates via the EMG2 webpage

- 3.18 The EMG2 webpage will be kept up to date with information about the proposals in general, including details about the statutory consultation process (including dates and venues) once confirmed.
- 3.19 All material used as part of the statutory consultation process will be available via the EMG2 webpage from the beginning of that formal consultation period and maintained throughout the period until the deadline for responses expires. Specifically, this will include electronic copies of the exhibition boards used at in-person and virtual events. It will also be possible to submit comments via the webpage, and so those unable to attend the in-person event will be able to both see the same consultation material and comment on it online.
- 3.20 During the consultation period, members of the public and all consultees will be able to use the comments form on the webpage (www.segro.com/emg2) to leave comments or ask questions this form will replicate the same hard copy form made available during the in-person exhibition events.

Public Exhibitions

- 3.21 The Applicant plans to hold two in-person public exhibitions and the intention is for these to be held a few weeks apart during the consultation period.
- 3.22 Dates and venue details of two public exhibitions will be confirmed in due course, but subject to availability of a suitable venue, the intention is for an exhibition to be held in Diseworth which is the closest community to the EMG2 main site, and another at a hotel located close to the site which it is intended will be a convenient, larger venue in a central location for residents from nearby surrounding villages.
- 3.23 The final venues will be chosen for the exhibitions on the basis that they are close to the proposed development site and have sufficient space to accommodate potentially large groups of people safely including sufficient access and car parking, while also accommodating the display of large-scale exhibition boards.
- 3.24 Subject to venue availability, the exhibitions will run during the afternoon and through to the early evening for each event, typically for around 6 hours for example, 1.30pm until 7.30pm. The exhibitions will not be held during school holidays or public holidays. Any event held on a Saturday is likely to start and finish earlier than those during the working week for example, 11.30am until 5.00pm.
- 3.25 The exhibitions will provide an opportunity for people to see details of the emerging proposals, ask questions from representatives of the Applicant's professional team, and provide comments and feedback. Exhibition material will be prepared and displayed on large-scale boards at each public exhibition and will include draft plans and drawings required as part of the DCO process.
- 3.26 Representatives of the Applicant's professional team will be available to answer questions by visitors to the exhibitions. People will be asked to leave written comments and suggestions at

the exhibitions via a paper feedback form, or provide comments afterwards by letter or via the comments form on the webpage. They will be asked to respond within the consultation timeframe which will extend to 6-weeks (well in excess of the required minimum of 28 days).

Webinar Session

- 3.27 To increase accessibility for those unable to attend physical events, the Applicant will also organise an online 'webinar' session. A registration link for the webinar session will be provided on the EMG2 webpage and the Community Awareness Leaflet will explain and direct residents to the EMG2 webpage in order for them to register to participate in the webinar session in advance.
- 3.28 The total number of webinars will, in part, be informed by the levels of demand and interest in attending, but a minimum of one is proposed and expected to last approximately 1.30-2 hours. It is proposed that the webinar will be held in the second half of the consultation period for those who were unable to attend an in-person event.
- 3.29 The webinar session will use a format which is expected to include the following:
 - A weblink or similar that the local community can use to register in advance for the webinar;
 - The Scheme email address and EMG2 webpage where questions in advance of the webinar can be submitted by members of the public;
 - An email link will be sent to registrants in order to access the webinar;
 - A brief presentation on key elements of the proposals by representatives of the Applicant's professional team from a range of disciplines;
 - Questions posed prior to the webinar will then be answered by the Applicant's professional team;
 - Webinar participants will be provided the opportunity to ask further questions of the Applicant's professional team during the webinar, most likely via a written "question and answer" function during the event. These comments will be recorded and reported on in the Consultation Report submitted to the Secretary of State as part of the DCO;
 - A recoding of the webinar or summary Question and Answer (Q&A) of the event will be
 posted on the EMG2 webpage for review within 1 week of the webinar session. This
 summary is provided for those unable to attend the events and could be used by
 residents to inform their comments.
- 3.30 If there is significant interest in attending the webinar, to keep numbers manageable, the number of webinars will be increased, and each additional session will be advertised via the EMG2 webpage. A version of the same information boards, plus the same drawings and documents, as used during the public exhibitions will be available to support each online webinar and will also be available on the EMG2 webpage.
- 3.31 Webinars are currently expected to feature on a weekday late during the 6 week consultation period in an early evening slot to avoid normal working hours (e,g, between 18:00-19:30).

What we will consult on

3.32 A principal purpose of the various forms of consultation as set out in this SoCC is to gain a further understanding of specific issues and concerns held by the communities close to the land

where the proposed development is situated, with a view to addressing and ameliorating these wherever possible.

- 3.33 The statutory consultation will include updated and further progressed information about the proposed development to help inform local people and other consultees, and to aid them in making comments. This will include a range of draft plans, reports and other documentation, including the latest draft ES documents comprising the preliminary environmental information (see paragraph 2.12).
- 3.34 The draft ES documents, will provide an overview of the site characteristics and findings regarding the existing 'baseline', and set out the ongoing range and scope of works being undertaken and planned to inform the ES in due course. The material will be prepared in the context of the EIA Scoping Opinion provided by PINS, and the comments provided by consultees. The ES will be based on the work undertaken to date at that stage, and is intended to provide a sound overview of the baseline conditions, enable some early judgements about the most likely potential effects, and initial descriptions of likely or emerging mitigation measures, as well as early indications, where available, of potential effects.
- 3.35 The proposed documents to be included and consulted on during the statutory consultation period is set out below. It is not intended that these Scheme drawings/documents will be the final versions. They will be the latest available drafts and will be under-going further updates as the Scheme progresses towards submission and to reflect consultation responses, as well as ongoing detailed work (for example regarding the emerging detail of draft highways mitigation works).

How we will advertise the Consultation Activities

- 3.36 Consultation will be advertised in the following way:
 - Issue a community awareness raising leaflet (see further information below) to all households and businesses within the Core Area (identified on the plan at Figure 3 above) containing key information to summarise the proposed development and providing information on how individuals can communicate with the Applicant and make representations.
 - Written contact with all local MPs, County, District and Parish Councillors
 representing communities within the identified Core Area, and in other surrounding
 nearby communities beyond the Core Area, including in areas where leaflets will not
 have reached every address. This will make them aware of how, where, and when
 they and their constituents can access the Scheme information, and comment upon it.
 - Publicise our intention to submit an application for a DCO for a NSIP and a MCO in accordance with the requirements of the PA 2008. This will include writing to statutory consultees pursuant to section 42 of the PA 2008 (including prescribed consultees, local authorities listed under section 43 of the PA 2008 and persons with an interest in the land as described in section 44 of the PA 2008) as well as publishing notices in local newspapers, a national newspaper and the London Gazette pursuant to section 48 of the PA 2008.
 - Publish a newspaper notice in the Leicester Mercury and Loughborough Echo (local press), and in the Derby Telegraph and Nottingham Post to ensure a wider circulation and awareness raising. These notices will advise the start of the statutory consultation period before it commences. This notice will also include details of the planned public exhibitions and online webinar. The distribution areas for these newspapers extend well beyond the Core Area and will cover a large number of surrounding communities. The Applicant will also publish a notice pursuant to section 47 of the PA 2008 detailing

where this SoCC can be inspected online on the EMG2 webpage and also how hard copies can be viewed at the exhibitions, in deposited locations or requested.

- Site notices (or similar notices) informing residents of the upcoming exhibitions and online webinars, as well as details of the EMG2 webpage, phone number and contact email address will also be displayed in locations around the site, including at the existing EMG1 employment site which is known to employ people from across a large number of local communities. The site notices will be displayed before the start of the statutory consultation period, and the Applicant will ensure Parish Councils receive copies of notices with a view to them displaying them locally if they are able.
- Social Media and other online platforms, the Applicant will make use of their existing 'X' and LinkedIn channels to raise awareness of key milestones and events during the consultation and planning process, and direct people to the EMG2 webpage for details and more frequent updates.
- **Information about the consultation** will also be uploaded on to the EMG2 webpage in advance of the start of the statutory consultation period.
- 3.37 This approach will ensure notices appear in the local press in the immediate vicinity of the proposed development, but also in other communities well beyond that immediate area. Notices will be included in the newspaper publications online if possible.
- 3.38 In addition, as referred to above, all consultation information, including details of exhibitions will be available to the public on the EMG2 webpage. This webpage will be kept regularly updated with new information or documentation added to it.
- 3.39 Respondees will be able to submit representations and comments via the following methods:
 - By hand (or post see below) via a printed comments form available at the public exhibitions;
 - Online via the comments form on the EMG2 webpage: www.segro.com/slpemg2
 - By post to a PO Box to be established for the statutory consultation period;
 - By telephone: 02475 529730;
 - In person at the public exhibitions described above;
 - During the online webinar.

Community awareness leaflet

- 3.40 In advance of the start of the statutory consultation period, a community awareness leaflet will be delivered to every residential and business address within the Core Area.
- 3.41 This leaflet will provide a summary of the development proposals, give details of where documents and information can be viewed, including the forthcoming exhibitions and online webinar events. The leaflet will also include the webpage address as well as a phone number and email address for residents who wish to contact the Applicant's team with any queries. In addition, copies of the community awareness leaflet will be made available at the public exhibitions.

3.42 Copies of the leaflet will also be shared with the Parish Councils inside and outside the Core Area both in hard copy and electronically, to ensure wider awareness of the consultation process in other communities.

Consultation documents placed in accessible public locations

- 3.43 It is proposed that copies of the consultation documents will be deposited as follows:
 - a) Hard copies of documents, including the SoCC, will be available at NWLDC customer centre and Castle Donington Library, which is the nearest library to the site:

- b) 5 USB sticks containing all the consultation documents will also be provided to each of the Parish Councils in the Core Area both for use by the Parish Council, but also with a view to them being made available to the local community at the Parish Council's office or at a village hall where practical to do so. More USBs can be made available to Parish Councils on request. USB sticks will also be available on request at the public consultation events.
- c) In addition, if requested, consultation documents can be provided by the Applicant via a suitable file sharing webpage link, such as *wetransfer*. If there are particular issues with downloading, printing documents or viewing online, at the discretion of the Applicant hard copies of any specific documents requested can be made available subject to a small printing charge (50p per A4 sheet, 75p per A3 sheet and if plans are requested at a larger scale, a charge of £5 per plan will be made). Cases of hardship will be considered on their individual basis and the Applicant may use its discretion on whether or not to charge for hard copies.
- 3.44 The Applicant will work with the local authorities and Parish Councils to ensure all documentation (including the Community Awareness Leaflet) is accessible to any identified harder to reach groups which represent people with protected characteristics under equalities law within the Core Area. This may include the provision of documents being made available in other formats as required, such as hard copies for those without computer access, large text format, or in braille. No harder to reach groups have been identified by the District or County Councils. As referred to above, for those with limited internet access, consultation documents will be available on a USB stick on request at the exhibitions, and by contacting the Applicant with name and address details.

Social Media

3.45 The Applicant will utilise its corporate social media platforms (X and LinkedIn) to raise awareness of key milestones and engagement events in the local community and allow a wider audience beyond the Core Area to be accessed. This will ensure a wider reach both

- geographically, but also demographically, with social media more likely to reach many younger groups and communities than traditional press adverts or notices.
- 3.46 The social media channels will be used to publicise the statutory consultation period and key milestones, and will direct people to the EMG2 webpage for more details about the proposals and the process. Social media users will have the option to "follow" these channels to be kept up to date about the proposals.

Other meetings

3.47 Where appropriate opportunities arise, the Applicant will attend local meetings to discuss the proposals, such as those held by local authorities or Parish Councils, particularly where this would supplement the consultation exhibitions and further enhance engagement and awareness of the proposals. This would represent a continuation of the engagement activity already underway.

When we will consult and for how long

- 3.48 Non-statutory consultation and engagement is ongoing and will continue with key stakeholders up to the submission of the DCO and MCO applications (see figure 2, paragraph 3.16 and table 1 above).
- 3.49 The statutory consultation is currently planned to commence in February 2025 for a period of 6 weeks. This is significantly greater than the statutory minimum requirement of a 28-day period.

Taking account of responses to the consultation and publicity (Consultation Report)

- 3.50 Dialogue and consultation with a wide range of parties and stakeholders has begun and will continue throughout the period in advance of, and beyond, the statutory consultation process described in this SoCC. The ongoing engagement, non-statutory consultation and statutory consultation activities will be summarised in a 'Consultation Report' which is required by the PA 2008 to accompany the application for a DCO and will be submitted to the Secretary of State.
- 3.51 The initial informal engagement undertaken by the Applicant has already directly informed some key aspects of the emerging design and composition of the Scheme. Early views, ideas or preferences expressed by local organisations and individuals have been considered and acted upon. For example, the local importance attached to the existing route of Hyam's Lane which runs across the site has been clearly expressed through the initial engagement undertaken, and so early design proposals which included the route being diverted have since been replaced and the proposals now see Hyam's Lane retained without diversion from its current alignment. Similarly, early (and ongoing) engagement with local bus operators has directly helped inform how sustainable transport measures and accessibility is being incorporated into the development proposals.
- 3.52 Further comments and representations received through the Statutory Consultation stage will be properly recorded and considered by the Applicant to inform the evolution of the Scheme. Comments will be summarised and reported in the 'Consultation Report' which will be submitted to the Secretary of State as part of the DCO application. Where appropriate, the Applicant will

respond directly to the points made or questions asked, particularly where specific proposals or amendments are suggested. An explanation of how consultation input and representations received have shaped and influenced the proposed development will be provided in the Consultation Report. A summary of main themes arising from consultation with the local community will also be published on the EMG2 webpage 4 to 6 weeks after the consultation period closes.

Application Submission

- 3.53 The third stage of public consultation will be undertaken by PINS after the application has been submitted and accepted, and this is split into two parts.
- 3.54 Firstly, within the 'Pre-examination' stage, members of the public are able to register with PINS to become an 'Interested Party' by making a Relevant Representation. A Relevant Representation is a written summary of a person's views on an application. All Interested Parties are invited to attend a Preliminary Meeting which is run and chaired by the Examining Authority appointed by PINS.
- 3.55 Secondly, during the Examination stage, Interested Parties who have registered by making a Relevant Representation are invited to provide more details of their views in writing, and some may be invited to participate in the Examination hearings by the Examining Authority.

SEGRO is proposing to develop a second phase to East Midlands Gateway (EMG1) known as EMG2. The land within the second phase forms part of the East Midlands Freeport and will contribute towards economic growth in the East Midlands (including through job creation) and long-term sustainability benefits. The proposal includes the provision of much needed employment space as well as improvements to the existing rail freight terminal at EMG1.

EMG2 has been identified by the Secretary of State as a project of national significance for which an application will be made to the Secretary of State for a Development Consent Order (DCO) pursuant to the Planning Act 2008. Consultation on the proposals for EMG2 will commence on 3rd February 2025 and end on 17th March 2025.



- Employment Floorspace:

 EMG1), with an allowance for
 105,000 sq m of additional
 mezzanine floors.
- Bus Interchange Terminal:
 A new bus terminal at the site entrance, replicating and building upon the sustainable travel strategy already in place at EMG1.
- Landscaping and Biodiversity:
 Extensive landscaping around site boundaries, incorporating both new and preserved natural features to enhance biodiversity. This will include a substantial landscape screen with earthworks bunding on the western and southern edges closest to Diseworth.

 Hyam's Lane will be retained to allow pedestrian and cyclist access through the site. Landscaping will include Sustainable Drainage Systems (SuDS).
- Vehicular Access: Direct from the A453, with new on-site road, walking and cycling infrastructure.
- Highway Improvements:
 Upgrades to the road network, including enhancements to Junction 24 of the M1 to increase traffic capacity and reduce congestion.
- Rail Freight Terminal
 Enhancements: Improvements
 to the existing EMG1 rail terminal
 to boost operational capacity and efficiency.



1 Introduction

- 1.1 SEGRO Properties Limited and SEGRO (EMG) Limited (referred to as "SEGRO" or "the Applicant") are preparing to make applications to the Secretary of State for a second phase of the East Midlands Gateway Logistics Park ("EMG1") which is a Strategic Rail Freight Interchange ("SRFI") located to the north of East Midlands Airport.
- 1.2 EMG1 is a nationally significant infrastructure development comprising a rail freight terminal and warehousing. It was authorised by The East Midlands Gateway Rail Freight Interchange and Highway Order 2016 (SI 2016/17) ("the EMG1 DCO") and is substantially complete.
- 1.3 The first application, the applicant for which is SEGRO Properties Limited, will be submitted pursuant to Part 5 of the Planning Act 2008 ("the 2008 Act") for a Development Consent Order ("DCO"). The second application, the applicant for which is SEGRO (EMG) Limited, will be submitted pursuant to Regulation 4 of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 (the "CRDCO Regulations") for a Material Change Order to the EMG1 DCO ("MCO").
- 1.4 The proposed development for which the two applications are to be made is referred to as 'East Midlands Gateway 2' or 'EMG2' and comprises the following elements:

Within the DCO Application

- EMG2 Main Site a new multi-unit logistics/industrial development located south
 of East Midlands Airport and the A453, and west of the M1 motorway. This part
 of the site falls within the 'East Midlands Airport and Gateway Industrial Cluster'
 (EMAGIC) site, which forms part of the East Midlands Freeport designated by the
 Government in 2022; and
- Highways Works works to the highway network including significant improvements at Junction 24 of the M1 (referred to as J24 Improvements) and the road network interacting with that junction. Due to the scale (and area) of the Highways Works, they represent an NSIP in their own right; and

Within the MCO Application

• EMG1 Works – the proposals include changes within EMG1, incorporating additional warehousing on Plot 16 together with works to increase the permitted height of the cranes at the rail-freight terminal, improvements to the public transport interchange and site management building.

2 Statutory consultation

- 2.1 SEGRO formally consulted on its emerging proposals for EMG2 between 3 February 2025 and 17 March 2025 (the "statutory consultation period")¹.
- 2.2 The six (6) week statutory consultation period was completed in accordance with the Statement of Community Consultation ("SoCC") published on 18 December 2024. The SoCC remains available to download on the EMG2 webpage www.segro.com/slpemg2.
- 2.3 SEGRO is in the process of preparing an Adequacy of Consultation Milestone ("AoCM") document for submission to the Planning Inspectorate ("PINS"). The AoCM will set out the consultation activities completed by SEGRO, including informal non-statutory consultation activities and other activities undertaken by SEGRO to raise awareness and consult with statutory consultees, key stakeholders, interested parties and members of the public before and during the formal statutory consultation period. A full list of the statutory consultees will be appended to the AoCM.
- 2.4 A commitment was given in the SoCC to make available a summary of the main themes arising from the statutory consultation processes following the end of the statutory consultation period. This document has been prepared to give effect to that commitment.
- 2.5 A more formal Consultation Report is being prepared and will accompany the DCO and MCO applications in due course. That report will provide more detail on the statutory consultation responses and how the Applicant has had regard to them in preparing the DCO and MCO applications to satisfy the requirements of the 2008 Act and the CRDCO Regulations.

3 Main themes

3.1 The main themes arising from the responses received to SEGRO's statutory consultation are summarised in the Appendix to this document.

3.2 Where a theme is specific to the DCO application or the MCO application then this has been identified. For clarity, references to the Environmental Statement ("ES") chapters are common to both the DCO and MCO applications as a single ES will cover both applications.

4 Conclusion

4.1 SEGRO is considering the statutory consultation responses received and is having regard to any relevant responses in developing its proposals for EMG2 in accordance with its duty set out in section 49 of the 2008 Act. Further engagement is also being undertaken where appropriate to better understand the issues raised in the statutory consultation responses.

Visual impact and landscaping

Concerns about the visual impact from Diseworth and the lack of a sufficient buffer.

Many respondents were of the view that it is the wrong place/site in landscape/visual terms for this type of commercial development. Some respondents questioned if the scheme could be built lower into the ground to further mitigate visual impact.

Some acknowledged and welcomed the consideration that had gone in to the design of the mounding and landscape buffering to Diseworth, and that this had improved by moving development further away during the design process to date, but others still felt it needed to move further to the east and away from Diseworth if it is to happen at all. Some respondents requested that the bunding be higher (like that around Lockington).

Suggestion that the buffer planting needs to include more larger tree stock from the outset and that consideration be given to winter conditions when trees not in leaf.

The visual impact and landscaping of the scheme are being considered, including the form / height of the perimeter mounding.

The landscape and visual impacts will be fully assessed within the Environmental Statement

Concerns that the EMG1 landscaping had not delivered on its promises, and the same could happen with EMG2.
